**STATEMENT OF AGREEMENT  
BETWEEN  
SAINT LEO UNIVERSITY  
AND  
THE APPRENTICE SCHOOL  
HUNTINGTON INGALLS INDUSTRIES NEWPORT NEWS  
SHIPBUILDING**

Whereas Saint Leo University and The Apprentice School/Huntington Ingalls Industries - Newport News Shipbuilding share the broad educational mission of providing opportunities for postsecondary learners to pursue knowledge and gain skills toward more rewarding lives through self-enrichment; and

Whereas Saint Leo University and The Apprentice School/ Huntington Ingalls Industries - Newport News Shipbuilding may provide more fruitful educational opportunities through institutional cooperation and program coordination; and

Whereas Saint Leo University and The Apprentice School/ Huntington Ingalls Industries - Newport News Shipbuilding recognize the benefits of facilitating course and credit transfer between the respective institutions;

Now, therefore, Saint Leo University and The Apprentice School/ Huntington Ingalls Industries - Newport News Shipbuilding hereby agree as follows:

1. That Saint Leo University will accept The Apprentice School/ Huntington Ingalls Industries - Newport News Shipbuilding courses and earned credits on a course by course basis upon receipt of the student's official Apprentice School transcript;
2. That Saint Leo University recognizes these elective credits as applicable toward its Associates of Arts, Bachelor's of Arts and Bachelor's of Science degree programs. Some, but not all, may satisfy Saint Leo University general education requirements;
3. That Saint Leo University restricts this acceptance of transfer credit to an aggregate total of 33 semester hours of credit toward the Associate of Arts, Bachelor's of Arts or Bachelor's of Science degrees per student in accordance with its long-standing transfer credit policy pertaining to technical or military course training;
4. That this agreement will be reviewed biannually or whenever major changes are proposed by either institution;
5. That this agreement will remain in effect until modified or rescinded by the duly authorized signatory of either institution.

Both parties are interested in a long-term relationship, and hence this agreement is without a specified termination date. However, either party may terminate the relationship at anytime by a notification letter signed by either of the signatories below or their designation.


